RESPONSE: Armstrong Telecommunications has not obtained any waiver or exceptions from the FCC pertaining to high-cost or low-income support.

RESPONSE: A list of awarded blocks follows as Attachment A.

3. Will Armstrong Communications elect to participate in the Emergency Broadband Benefit Program in Pennsylvania as an ETC? If so, does the company's ETC service area include Lifeline-only support for service areas in addition to the high-cost service areas?

RESPONSE: Armstrong is in the process of electing to participate in the Emergency Broadband Benefit Program (EBB) in Pennsylvania. Armstrong's ILEC affiliates are currently ETCs and Armstrong Telecommunications, Inc. (CLEC) is currently an ETC in a limited area. The EBB program would apply to broadband services in the entire service area for the ILECs and CLEC. The EBB Program does not have an impact on Lifeline service.

4. Is Armstrong Telecommunications also seeking to amend its CLEC service area with this application?

RESPONSE: Armstrong is not seeking to amend its CLEC service area. Armstrong is already authorized to offer services in the service areas of the applicable ILECs.

5. Did Armstrong Telecommunications serve its application on the applicable ILECs?

RESPONSE: Armstrong did not serve its application on any ILECs since it is already authorized to provide services in the applicable areas.
