This attachment contains additional information in support of Sections 8 (Applicant's Present Operations), 15 (Start Date) and 16 (Further Developments) of Data Network Solution's Applications at Docket Nos. A-2020-3020738 (CLEC) and A-2020-3020740 (IXC).

This Commission had previously issued certificates of public convenience to Applicant at Docket Nos. A-2008-2054588 (IXC), A-2008-2054592 (CLEC VZ Pa) and A-2008-2054593 (CLEC VZ North).

At the Public Meeting of July 11, 2019, at Docket No. M-2019-3010251, the Commission issued a Tentative Order titled *Cancellation of Certificates of Public Convenience for Telecommunications Public Utilities Reporting Zero Intrastate Operating Revenue*. Applicant was one of thirty utilities listed in Appendix A. Unfortunately, unknown employees of Applicant did not realize the significance of the Tentative Order and did not bring it to the attention of Applicant's management.

On September 25, 2019, the Commission issued Final Orders cancelling the certificates of public convenience at Docket Nos. A-2008-2054588 (IXC), A-2008-2054592 (CLEC VZ Pa) and A-2008-2054593 (CLEC VZ North).

On July 7, 2020, having obtained counsel, Applicant submitted new Applications for certificates of public convenience at Docket Nos. A-2020-3020738 (CLEC) and A-2020-3020740 (IXC). Applicant will be providing intrastate telecommunications service for compensation and will have intrastate operating revenues to report on the different reports that are required by the Commission.

Applicant's management has made internal changes for the handling of regulatory mail and the prompt and accurate submission of required regulatory filings, including, but not limited to, assessment reports.
