Section 1307(e) reconciliation for the 12 months ending December 31, 2021

## Dear Secretary Chiavetta:

Attached please find the reconciliation filing for the calendar year ended December 31, 2021, in conjunction with Pennsylvania American Water's Negative Surcharge for Deferred Tax Credit for its water service territory. This surcharge, as approved at Docket No. R-2020-3019369 was applied to customers' bills during the period January 28, 2021 through December 31, 2021.

As approved at Docket No. R-2020-3019369 and ordered by the Commission on February 25, 2021, the Company was entitled to recoup the revenue increase not billed from January 28, 2021 through the effective date of new rates, March 8, 2021. The calculated recoupment surcharge included an offset of the Negative Surcharge for Deferred Tax Credit that would have been returned to customers during the recoupment period, and is therefore included in the reconciliation for the period January 28, 2021 through March 7, 2021.

Consistent with page 40 of Tariff Water-PA P.U.C. No. 5, the reconciliation amount of \$208,073, plus interest, will be deferred to the Company's next base rate case.
