Dear Chairman Kissling:

On May 13, 2022, Aqua Pennsylvania Wastewater, Inc. ("Aqua"), North Heidelberg Sewer Company ("NHSC"), the Bureau of Investigation and Enforcement of the Public Utility Commission, the Office of Consumer Advocate and Metropolitan Edison Company filed a Joint Petition for Approval of Settlement of the above referenced proceedings currently pending before the Public Utility Commission ("PUC"). The Joint Petition asks the PUC to approve Aqua's acquisition of the wastewater system currently owned by NHSC.

A Plan for Improvements of the wastewater system is included as Appendix B to the Joint Petition and enclosed here. Under the terms of the Joint Petition, Jefferson Township, has the opportunity, if it chooses, to submit comments to the PUC for the PUC's consideration in approving the Plan for Improvements. 
