Re: Implementation of Chapter 32 of the Public Utility Code Regarding Pittsburgh Water
and Sewer Authority – Stage 2; Compliance Tariffs

Dear Ms. O'Dell:

On November 15, 2022, Pittsburgh Water and Sewer Authority (PWSA or the Company) filed Supplement No. 10 to Tariff Water – Pa. P.U.C. No. 1 (utility code 2220554), Supplement No. 10 to Tariff Wastewater – Pa. P.U.C. No. 1 (utility code 2320555), and Supplement No. 2 to Tariff Storm Water – Pa. P.U.C. No. 1 (utility code 2423775) to become effective on January 14, 2023 (Compliance Tariffs). The Compliance Tariffs were filed pursuant to the Commission's Order entered July 14, 2022, which approved the "Joint Petition for Settlement Regarding PWSA's April 9, 2021 Stage 2 Compliance Plan: Chapters 14 & 56, DSLPA and Collections" (Settlement) filed in the above dockets.

In accordance with the Settlement, PWSA previously circulated drafts of the proposed tariff revisions to the parties and to the Commission's Bureau of Consumer Services (BCS). PWSA received comments from BCS, and changes reflecting certain of those comments are reflected in the Compliance Tariffs. The water and wastewater supplements also include additional language agreed to informally with BCS stating that PWSA will provide written notice to an Applicant who is rejected, consistent with the Commission's regulations.

Commission Staff has reviewed the tariff revisions and found that suspension or further investigation does not appear warranted at this time. Therefore, in accordance with 52 Pa. Code Chapter 53, Supplement No. 10 to Tariff Water – Pa. P.U.C. No. 1, Supplement No. 10 to Tariff Wastewater – Pa. P.U.C. No. 1, and Supplement No. 2 to Tariff Storm Water – Pa. P.U.C. No. 1 are effective by operation of law as of the effective date contained on each page. However, this is without prejudice to any formal complaints timely filed against said tariff revisions.
