Aqua Pennsylvania Wastewater, Inc. ("Aqua") was served yesterday with a Joint Motion for a Stay of the above referenced proceeding ("Motion"). The Motion proposes expedited review and requests that answers to the Motion be provided by Tuesday, January 31, 2023.

Aqua does not oppose an accelerated due date in advance of the twenty (20) day answer period provided for in the Pennsylvania Public Utility Commission's regulations. **However, Aqua requests that answers or other responsive pleadings to the Motion be filed and served by close of business on Thursday, February 2, 2023, since the earlier requested date cannot be reasonably met by Aqua.** Aqua will need to discuss this matter with DELCORA and its lead counsel. 
