By Commission orders entered on June 15, 2023, the Commission instituted an investigation of PWSA’s proposed rate request, assigned the matter to the Office of Administrative Law Judge and directed PWSA to file tariff supplements announcing that the tariffs filed on May 9, 2023 were suspended until February 8, 2024. A prehearing conference was held on June 29, 2023 wherein PWSA agreed to voluntarily extend the suspension period until February 15, 2024 in order to accommodate the Commission’s public meeting schedule and support the litigation schedule to be adopted for this proceeding.
