#### JOINT STIPULATION FOR THE ADMISSION OF TESTIMONY AND EXHIBITS INTO THE EVIDENTIARY RECORD

TO DEPUTY CHIEF ADMINISTRATIVE LAW JUDGE MARK A. HOYER:

This Joint Stipulation for Admission of Testimony and Exhibits into the Evidentiary Record ("Joint Stipulation") is entered into by all of the parties in this proceeding, including Pike County Light & Power Company ("PCL&P" or the "Petitioner"), the Office of Consumer Advocate ("OCA"), and the Office of Small Business Advocate ("OSBA") (collectively, "Joint Petitioners"), by their respective counsel. Joint Petitioners respectfully request that Deputy Chief Administrative Law Judge Mark Hoyer admit into the evidentiary record of this proceeding written testimony and exhibits as identified below.

This Joint Stipulation includes the following Appendices:

- Appendix B PCL&P Testimony Verifications

#### I. PROCEDURAL HISTORY

1. On April 13, 2023, Pike filed a Petition for Approval of its Default Service Plan and Waiver of Commission Regulations ("Petition"). The Petition was filed pursuant to Section 2807(e) of the Public Utility Code and 52 Pa. Code §§ 54.181-54.190. Through its Petition, Pike is seeking approval from the Pennsylvania Public Utility Commission ("Commission") regarding its proposed default service plan (DSP) for June 1, 2024 through May 31, 2027, and certain waivers

related to default service. The Petition was published in the Pennsylvania Bulletin on May 13, 2023, with an Answer/Protest date of June 9, 2023.

- 2. On May 3, 2023, the Office of Small Business Advocate ("OSBA") filed a Notice of Intervention, Public Statement, Notice of Appearance, and Verification. The OSBA separately filed an Answer to the Petition on June 7, 2023.
- 3. On May 19, 2023, the Office of Consumer Advocate ("OCA") filed an Answer, Notice of Intervention, Public Statement, and Verification.
- 4. No other parties or individuals filed a protest or notice of intervention or other correspondence with the Commission.
- 5. On May 30, 2023, Pike served the public and confidential versions of its written Direct Testimony as part of this proceeding. Subsequently, on June 8, 2023, Pike filed an unopposed Motion for Protective Order seeking to limit the availability of proprietary information.
- 6. This matter was assigned to the Office of Administrative Law Judge and further assigned to Deputy Chief Administrative Law Judge Mark Hoyer ("ALJ Hoyer"). A telephonic prehearing conference notice was issued setting forth a prehearing conference for June 15, 2023. Subsequently, Administrative Law Judge Mark Hoyer issued a Prehearing Conference Order directing the parties to file Prehearing Conference Memorandums by no later than 12:00 PM on Wednesday, June 14, 2023.
- 7. A prehearing conference was held as scheduled on June 15, 2023. PCL&P, the OCA and OSBA were represented at the conference.
- 8. On June 21, 2023, ALJ Hoyer issued a Prehearing Order that, *inter alia*, set forth a litigation schedule and modified the Commission's discovery rules. Separately, on June 23, 2023, ALJ Hoyer issued a Protective Order.

- 9. The parties served written direct, rebuttal, and surrebuttal testimony and exhibits consistent with the procedural schedule in this proceeding.<sup>1</sup>
- 10. On August 24, 2023, the parties agreed to waive cross examination and requested that ALJ Hoyer cancel the evidentiary hearing scheduled for August 30, 2023.
- 11. In response, ALJ Hoyer instructed the Joint Petitioners to submit a Joint Stipulation for the Admission of Testimony and Exhibits into the Evidentiary Record no later than 12 P.M. on August 29, 2023, which, upon receiving, ALJ Hoyer would cancel the evidentiary hearing.
- 12. A proposed order is attached to the Joint Stipulation as Appendix A ("Proposed Order"). The testimony verifications of PCL&P Witnesses Russell Miller and Noel P. Chesser are attached as Appendix B to the Joint Stipulation. The testimony verifications of OCA witness Serhan Ogur and OSBA witness Mark Ewen are attached to their pre-served testimony.

#### II. JOINT STIPULATION

NOW, THEREFORE, desiring to enter into this Joint Stipulation and intending to be bound hereby, the Joint Petitioners agree and stipulate to the following:
