Please accept this letter in lieu of Exceptions of the Pittsburgh Water and Sewer Authority (“PWSA”) in response to the November 28, 2023 Recommended Decision of Administrative Law Judge Gail M. Chiodo (“RD”) in the above captioned proceeding.

PWSA does not object to the recommendations of the RD regarding the future filing of its proposed PennVest Charge (“PVC”) Tariff Supplements to begin cost recovery through the PVC.<sup>1</sup> In addition, on December 7, 2023 and on behalf of all the Joint Petitioners, PWSA filed an Addendum to Joint Petition for Settlement in response to other recommendations in the RD.<sup>2</sup> PWSA respectfully requests that the Commission enter a Final Order in this proceeding as soon as feasible permitting PWSA to implement the rates in set forth in the Joint Petition for Settlement on or before February 15, 2024.
