PREHEARING MEMORANDUM OF THE PEOPLES INDUSTRIAL INTERVENORS

Pursuant to Administrative Law Judge ("ALJ") Mary D. Long's January 23, 2024, Prehearing Conference Order, the Peoples Industrial Intervenors ("PII") hereby submit this Prehearing Memorandum in the above-captioned proceeding.

I. HISTORY OF THE PROCEEDING

On December 29, 2023, Peoples Natural Gas Company, LLC ("Peoples" or "Company"), filed with the Pennsylvania Public Utility Commission ("Commission" or "PUC") Original Tariff GAS – PA P.U.C. No. 48 (the "Tariff") to become effective February 27, 2024, containing proposed changes in rates, rules, and regulations calculated to produce an overall revenue increase of approximately \$156.0 million annually. Peoples supplemented this request with the Direct Testimony of several witnesses, responses to filing requirements, and documentation regarding the Company's proposals. Additionally, Peoples proposed to unify the distribution rates and tariffs of its two divisions (*i.e.*, Peoples Natural Gas Division ("PNGD") and Peoples Gas Division ("PGD")).

Concurrently with the filing of this Prehearing Memorandum, PII is also filing a Complaint in this proceeding. A description of PII is set forth in Paragraph 5 of PII's Complaint. A Prehearing Conference has been scheduled in this proceeding for February 2, 2024.

III. PRIMARY SPEAKER

For purposes of the Prehearing Conference, Ms. Mincavage will be the primary speaker.

IV. ANTICIPATED ISSUES AND SUB-ISSUES

PII's preliminary review of the Company's filing indicates the need for Commission investigation into at least the following issues:

- (a) Whether the size of the requested rate increase is appropriate;
- (b) Whether Peoples' proposals are just, reasonable, and consistent with any surviving terms and conditions of the settlement approved by the PUC at Docket Nos. A-2013-2353647; A-2013-2353649; and A-2013-2353651;
- (c) Whether the merger of Peoples' PNGD and PGD divisions and allocations of the proposed increase among and within customer classes are just, reasonable, and non-discriminatory;
- (d) Whether the return on equity proposed by Peoples results in a fair rate of return; and
- (e) Whether Peoples' claimed cost of service is accurate, legitimate, and appropriately allocated.

PII reserves the right to raise and address other issues of concern during the course of this

proceeding.

V. PROPOSED WITNESSES

PII is in the process of selecting a witness to sponsor testimony in this proceeding. Once

PII retains its witness, it will immediately inform the parties and the ALJ of his/her name and

topics of testimony. PII also intends to participate in this proceeding through the submission of

discovery, cross-examination of other parties' witnesses, and the submission of briefs, exceptions,

and reply exceptions, if necessary.

VI. PROPOSED LITIGATION SCHEDULE AND DISCOVERY RULES

PII will cooperate with the ALJ and the parties at the Prehearing Conference to develop an

appropriate procedural schedule and discovery rules in accordance with the Commission's

regulations and any ALJ directives.

VII. POSSIBILITY OF SETTLEMENT

PII is willing to participate in discussions with the other parties to amicably resolve the

issues in this proceeding.
