I am writing a comment and complaint for the case of docket number M-2023-3038060.

On my father's 100th birthday October 6, 2022 he fell and was hospitalized and has been in nursing care ever since. His home was unoccupied from that date until it was sold on August 16, 2023.

I went into the house and shut all baseboard radiators except for a small one in the kitchen and bathroom and those were set on low. I left them on just enough so the pipes would not freeze. I also shut off the breakers for the hot water heater. I placed thermometers throughout the house and they consistently read 50 degrees, however we continued to receive large bills from PP&L. During the time period when PP&L was having billing issues and was sending 'estimated' bills a period from December 2022 – April 2023 we were billed \$2,767.17. We filed a complaint with the PUC in March 2023. The PUC assigned case # for the complaint was 3893885. We received a decision on 6/15/2023 against our claim and we did not file an appeal due to the PUC stating that the decision was due to actual meter readings and not out of line with historic usage. The PUC did not give our complaint an adequate review, because we explained that the house was now empty.

For the PUC to decide that it was in line with historic usage would be an admission of not having studied or reviewed our complaint.

I feel the PUC does not protect the consumer but has the utility company's best interest when it makes a decision. If the state of Pennsylvania compels PP&L to pay 17 million for billing errors the money should be used to compensate customers who were wrongly billed.


