I KNOW, BUT MY BILLS SKY-ROCKETED.

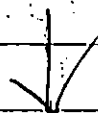

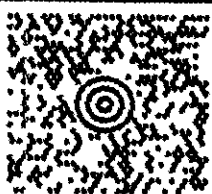

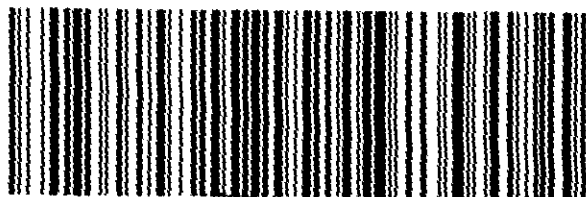
