We want to comment on the issues we had with PPL during the period of December 2022 through March 2023. During that period, we received no utility bills. We were concerned so we tried to contact PPL by phone if we were able to get through, we would be on hold for hours and numerous times then disconnected. A few times we could leave a message for a call back and when they would call back days later, they could not give us any information. This was so time-consuming and took time out of our workday. This was very stressful for us since it was during the winter months, and we knew the bills averaged higher during these months. When we did begin to receive invoices from PPL they were posted often, like every two weeks, and they were hard to follow since the totals included previous amounts that were already paid. I would call PPL for explanations, and they could not give me an intelligent answer.

I do not have copies of this period since I am paperless and PPL no longer has them posted, I only have the payments I made. During this whole experience, we were at PPL's mercy. We would appreciate it if the PUC looked into PPL records since we do not have much faith in their system. We know they continue to have issues. For instance, we received a notice that effective November 9, 2023, the supplier that we chose would begin, but the new supplier's service did not begin until November 28, 2023. We were required to pay the higher rate for weeks.

Thank you for looking into this matter and forcing PPL to take responsibility for this debacle.




