Our electric bills from PPL are outrageous. We live in our home over 30 yrs and we never had bills like this. The bills keep going up. We never asked to be on budget billing, yet we are charged \$60.31 for the budget billing settlement installment amount. At one point PPL was called and the customer service person said he took this off for us. yet they keep billing for this. Electric bills ranged over \$300.<sup>00</sup> - \$500.00 per month. We use LED lights, do 1 load of laundry a week on Saturday nights - off peak hours. Pipes are wrapped in the basement. When you tell them we conserve energy it's like they don't want to hear it. They say well this is your bill and you have to pay it. We need help to straighten this billing out. These bills are choking us.
