


THE TEAM

Alleged Violation Reports (AVRs)

As of September 1, 2020:

- ➤ We have received 17,717 AVRs since we were established on April 28th, 2018
- So far in 2020, we've received 5,630 AVRs
- ➤ All AVRs are reviewed and recorded






Summary

The Law

- ➤ Underground Utility Line Protection Law, 73 P.S. §§ 176 et seq.
- >"Act 50" of 2017
 - Six-year endeavor
 - HB 284, SB 242 of 2017
 - Signed by the Governor on October 30, 2017
 - Fully effective on April 28, 2018





Amendments to Underground Utility Line Protection Law


- ➤ Act 50 of 2017
 - Transferred enforcement authority
 - Removes certain exemptions
 - Creates a Damage Prevention Committee
 - Establishes administrative process for violations and penalties





Commission Goals in Enforcement

- ➤ Promote public safety
- Reduce damage to underground lines and facilities that can result in property damage, injury, and/or death
- ➤ Reduce number of "near-miss" events
- ➤ Heighten stakeholder awareness
- Develop a peer-based group of professional facility owners, excavators, and municipalities that will aid in the state-wide effort to minimize damage to underground utilities





The Damage Prevention Committee

- >"A new general in town"
- Section 7.8(a) of Act 50
- Established to assist in the enforcement efforts of the Commission and in matters related to damage prevention of underground lines and facilities





DPC Composition

- Comprised of 13 members representing the Commission, PA One Call System, PennDOT, facility owners, excavators, municipalities, and municipal authorities
- ➤ Members nominated by peers, approved by the Commission

DPC Duties and Responsibilities

- Section 7.8(b) of Act 50
- Review reports of alleged violations of Act 50
 - Violations resulting in injury or death are referred directly to I&E-Legal for formal prosecution
- ➤ Issue warning letters
- ➤ Issue informal determinations
 - Impose administrative penalties
 - Require the attendance of educational programs







DPC Goals

- > Reduce line hits and service interruptions
- Facilitate communication, cooperation, and coordination among stakeholders
- ➤ Heighten stakeholder awareness to the requirements of Act 50
- To promote and participate in education and training programs related to the prevention of damage to facilities to increase public safety









DPC Goals

- ➤ Work in conjunction with other damage prevention efforts
 - Common Ground Alliance (CGA), other damage prevention committees/councils, PA One Call Board, etc.
- ➤ Promote CGA Best Practices
 - Potholing, vacuum excavation, etc.
- Provide information and/or updates to legislative actions and maintain a consistent, state-wide damage prevention message







Administrative Process

- ➤ Section 7.8(c) of Act 50
- ➤DPC informal determination modifies, adopts, or dismisses recommendation of Damage Prevention Investigator (DPI)
- >DPC may assess administrative penalty of up to \$2,500 per violation
- > Alleged violator may accept or reject DPC informal determination
 - ➤ Accept: pay administrative penalty and/or attend educational program
 - ➤ Reject: matter referred to DPI for further action, if appropriate, matter is referred to I&E-Legal for prosecution

 - Technical representative preferred

DPC Statistics

- ➤ Since its initial meeting in November 2018:
 - Held 18 meetings
 - Reviewed 639 cases
 - Cited nearly 2,228 violations of Act 50
 - Levied \$1,234,025 in administrative penalties
