Unconventional Gas Well Fund

This fund was created by Act 13 of 2012 to provide for the collection and distribution of unconventional gas well impact fees. The fee revenue will be used by Commonwealth agencies for monitoring and oversight of unconventional gas wells, emergency responder training, and for rail freight assistance projects. Distributions will also be made to county conservation districts and to host counties and municipalities. Receipts deposited into the Unconventional Gas Well Fund are derived from an impact fee assessed to drillers of natural gas wells in the Marcellus (or equal) Shale regions of the Commonwealth. The fee, assessed per gas well, may be adjusted based on the number of wells and changes in the Consumer Price Index for all urban consumers in the Pennsylvania, New Jersey, Delaware and Maryland area.

As custodian of the Unconventional Gas Well Fund, the PA Public Utility Commission has the fiduciary responsibility to monitor and report on the receipts and disbursements of other agencies that utilize the fund.

(1) The calendar year 2021 impact fees for Rockdale Marcellus, LLC of \$1,428,100.00 remain unpaid pending the completion of the Rockdale Marcellus bankruptcy proceeding. This bankruptcy proceeding may substantially reduce or eliminate the 2021 Rockdale Marcellus contribution. Funds recovered, if any, will be deposited in the next calendar year for proportional distribution to all fund recipients. Losses for uncollected funds have been similarly apportioned to all fund recipients for this reporting year.

(2) Of the \$584,100.00 owed to the fund by Tilden Marcellus for calendar year 2021 impact fees, \$344,350.00 remains unpaid pending the completion of the Tilden Marcellus bankruptcy proceeding. This bankruptcy proceeding may substantially reduce the Tilden Marcellus contributions to the fund. Any funds received will be deposited in the next calendar year distribution. Losses for uncollected funds have been similarly apportioned to all fund recipients for this reporting year.

Marcellus Legacy Fund

This fund was created by Act 13 of 2012 to provide for the distribution of unconventional gas well impact fees to counties, municipalities, and Commonwealth agencies. The fee revenue will be used for statewide initiatives in the areas of acid mine drainage abatement, gas well management and plugging, development and rehabilitation of greenways and recreational trails, sewage treatment projects, replacement and repair of deteriorated bridges in municipalities with unconventional gas wells. Receipts deposited into the Marcellus Legacy Fund come from transfers from the Unconventional Gas Well Fund, a newly created fund under Act 13 and the Oil and Gas Lease Fund. The 2015-16, 2016-17 and 2017-18 Fiscal Codes modified the transfers from the Oil and Gas Lease Fund. The 2019-20 enacted budget included modifications to multiple environmental special funds, including a \$20 million reduction in the annual transfer from the Oil and Gas Lease Fund that is deposited into the Marcellus Legacy Fund then transferred to the Environmental Stewardship Fund. This budget maintains the annual \$15 million transfer from the Oil and Gas Lease Fund that is deposited into the Marcellus Legacy Fund then transferred to the Hazardous Sites Cleanup Fund.

As custodian of the Marcellus Legacy Fund, the PA Public Utility Commission has the fiduciary responsibility to monitor and report on the receipts and disbursements of other agencies that utilize the fund.




Usage of Funds Received for Reporting Year 2020


