3456	Facility Owner: Buckeye Partners, L.P. Excavator: Adam Mackiewicz Project Owner: Homeowner	On 5/4/18 at 213 Governor Drive, Allison Park, Allegheny County. The facility was not damaged. The excavator was doing work without a One Call notification ticket and was trying to use marks that were made several months previously for a fencing project that was done by a different company. The excavator used an auger within 2-3 feet of Buckeye's high pressure petroleum products pipeline when he was discovered by Buckeye Partners. PA One Call stated that this excavator never placed a One Call ticket.	Adam Mackiewicz - \$1,000.00 Section 5(2.1) 1st offense- \$1,000
2886	Facility Owner: Whitemarsh Township Excavator: Caddick Utilities LLC Project Owner: Aqua PA	On 5/7/18 at W. North Lane, Plymouth TWP, Montgomery County. Caddick Utilities hit and damaged an underground electric line for traffic signals at the intersection of W. North Lane and Butler Pike. Whitemarsh TWP's did not mark their facility.	To be discussed again at a future DPC meeting.
2200	Facility Owner: PA American Water Excavator: Kriger Pipeline, Inc. Project Owner: UGI Utilities Inc.	On 7/13/18 at Marion Street, Scranton City, Lackawanna County. Kriger Pipeline was removing asphalt out of the tolerance zone with an excavator when they struck a 16-inch cast iron water main. PA American Water stated, a hydro-hammer was used to break through the asphalt. UGI stated that the line was 12-inches directly under the concrete. Pictures show the water main at a very shallow depth and the Locate marks are barely visible in one picture, but both PAWC and UGI agree that the line was marked correctly. Although mechanical equipment had to be used to break through the asphalt, the excavator took a risk by not ascertaining the depth of the line prior to excavation. 207	Facility Owner: Peoples Gas Excavator: D&M Contracting Castelli Development Project Owner: PA American Water	On 9/4/18 at 4902 McAnulty Road, Whitehall Boro, Allegheny County.  D&M Contracting was excavating, when a 1-inch plastic gas service line was hit and damaged. Peoples Gas stated, D&M failed to protect and preserve the markings after excavation begun. Also, Peoples Gas felt this should have been a complex ticket due to the amount of one calls placed for the same area. JD Eckman was hammering within the tolerance zone of the gas line, but failed to determine the precise location of the UGI line. Also, they failed to call in another Routine Ticket to One Call, when the scope of the work went outside of the previous proposed excavation area; which would have allowed all of the facility members to come to the site to mark their utilities in the other areas JD Eckman would be excavating. Section 5.4 of the HDD Good Practices Guidelines explains that excavators should verify locates prior to drilling. Pictures provided by Columbia Gas show the gas service lines were accurately marked with flags in both the homeowners' grass on both sides of the streets and a refreshed paint marking across the road.
