



## Installing solar panels on your home can:

- Reduce your electric bill via net metering;
- Generate and sell solar renewable energy credits, if you own or lease your solar PV system;
- Increase the value of your home;
- Support economic growth through the creation of green jobs in Pennsylvania; and
- Protect the environment by reducing greenhouse gas emissions.

## Eight-Step Guide

Thinking about installing a solar photovoltaic (PV) system at home? Here is a guide to assist in the process:

1. Make your home more energy efficient before installing a solar PV system.
2. Research before investing, leasing or entering into a power purchase agreement for a solar PV system.
3. Learn about permitting and zoning issues/requirements before installing a solar PV system, and understand how the system interconnects with your electric utility's distribution system.
4. Review your current energy usage to help determine what size solar PV system to install.
5. Calculate the upfront costs.
6. Search for incentives, rebates and tax credits.
7. Be sure you know and understand what your responsibilities are if you purchase, lease, or sign a power purchase agreement for a solar PV system. This includes your costs associated with the municipal permitting and inspection process, connecting to the electric utility's distribution system, maintenance and any repairs to the solar PV system, as well as anticipated electric bill impacts.
8. Choose a reputable solar contractor/installer registered with the PA Attorney General with either North American Board of Certified Energy Practitioners (NABCEP) or UL PV certification. Try to get at least three quotes or proposals with references.
