Formal Complaint (FC) filed on 10/5/22, alleging, *inter alia*, that Philadelphia Gas Works (PGW) threatened to shut off Florence Ackridge's (Complainant) service and that there were incorrect charges on her utility bill account balance. The FC is an appeal of an informal Bureau of Consumer Services decision. As relief, the Complainant requested, *inter alia*, recalculation of her bills and issuance of a Commission payment arrangement. On 10/27/22, PGW filed an Answer and New Matter. The matter was assigned to the OALJ, with ALJ Guhl as presiding officer. A telephonic hearing was held in this matter on 1/12/23. On 5/15/23, the Commission issued ALJ Guhl's Initial Decision, which granted the FC, in part, and established a payment arrangement, and dismissed the FC pertaining to incorrect bills. On 5/25/23, the Complainant filed Exceptions to the Initial Decision. Replies to Exceptions were filed by PGW.

DLC filed Replies to Exceptions on 11/24/23.
