Those standards include a requirement that each segment of pipeline that becomes unsafe must be replaced, repaired, or removed from service. 49 C.F.R. § 192.703(b). Section 59.34 of the Commission regulations is inconsistent with the federal regulation regarding a pipeline operator's responsibility for pipeline safety.
