Between 6/1/18 and 9/30/20, the Commission’s Bureau of Consumer Services (BCS) received approximately twenty-two informal complaints from residential customers alleging that their electricity accounts had been switched to receive electric generation service supplied by Green Mountain Energy Company (Green Mountain) without authorization. After it was determined that the alleged unauthorized enrollments stemmed from Green Mountain’s marketing activities at in-person locations, where Green Mountain agents were utilizing eligible customer lists to obtain the information of prospective customers, BCS referred the matter to the Commission’s Bureau of Investigation and Enforcement (BIE). By letter dated 1/8/21, BIE notified Green Mountain of its informal investigation, focusing on Green Mountain’s marketing, sales and enrollment practices as an electric generation supplier in Pa. On 7/9/21, the Parties submitted a Joint Petition for Approval of Settlement (Settlement) and Statements in Support of the Settlement.
