I am pleased to submit for your review the Commission's Rate Comparison Report.

Act 201, signed into law on Nov. 30, 2004, added Section 308.1(b) to the Public Utility Code, 66 Pa. C.S. §308. Section 308.1(b) requires the Public Utility Commission to file an annual Rate Comparison Report (Report) with the Governor and the General Assembly on April 15, every year. The Report compares all categories of ratepayers for all electric and gas public utilities so that a reasonably accurate comparison of rates can be made between similar ratepayers receiving services in different service areas of the Commonwealth.

The first section of the Report provides information on electric service. The second section provides information on natural gas service. Each section contains a comparison table of all companies followed by individual company information.

## Introduction

To achieve an accurate comparison, the Commission established ratepayer categories and monthly usage parameters. These usage parameters include a demand component where applicable. The Commission also established that the rates used would be as of Jan. 31, 2008, and would be based on the Provider of Last Resort (POLR) default service for electric customers, or Supplier of Last Resort (SOLR) default service for gas customers<sup>1</sup>. All rates are for ratepayers not currently purchasing their gas or electric generation from competitive suppliers (non-shoppers) and reflect a monthly bill at the given usage parameters. The ratepayer classifications and usage assumptions are detailed below.

<u>Ratepayer Classification</u>	<u>Electric Usage</u>	<u>Gas Usage</u>
1. Residential	500 KWH	2 MCF
2. Residential Heating	2,000 KWH	15 MCF
3. Small Commercial	5 KW demand 1,000 KWH	150 MCF/year
4. Medium Commercial	25 KW demand 10,000 KWH	500 MCF/year
5. Large Commercial	500 KW demand 200,000 KWH	9,000 MCF/year
6. Industrial	1,000 KW demand 400,000 KWH	>9,000 MCF/year
7. Public Street Lighting (sodium vapor)	250 watts	N/A

KWH = Kilowatt hour, a standard measure of electricity usage calculated by multiplying total wattage by hours of use divided by 1,000, e.g. one 100-watt bulb will use 24 KWH in one month (30 days) if used eight hours a day [(100\*240)/1,000 = 24 KWH].

KW = Kilowatt (1000 watts), used as a demand measure for larger users of electricity. Essentially, it is a measure of the electrical capacity required by the customer at any instantaneous moment.

MCF = 1,000 cubic feet of gas, a standard measure of gas usage. It is the measure of the flow of cubic feet of gas through the meter.

Street lighting is determined as the cost of running one 250-watt sodium vapor light for a month.

<sup>1</sup> PPL Electric Utilities, PECO Energy, Metropolitan Edison Company, Pennsylvania Electric Company and West Penn Power rates are subject to rate caps resulting from restructuring decisions. All other electric and gas customers are subject to POLR or SOLR decisions.

The Commission issued a Secretarial Letter by certified mail to the appropriate contact for every electric and gas utility. Utilities with Internet access were asked to download and fill out a rate table based on the ratepayer categories and usage parameters above. Utilities then submitted the forms via email with subsequent printed copies mailed to the Commission. Utilities without Internet access were asked to fill out enclosed hard copies of the rate tables and to submit those hard copies to the Commission. The Commission is grateful for the timely response of the utility companies.

The following sections present the rate tables for each utility, so an accurate comparison between utilities can be made. Section 1 begins with a comparison table between all of the electric utilities. After the comparison table, Section 1 presents each of the electric utilities, in alphabetical order, with their individual rate tables and a brief description of the utility, the applicable tariff number, and any unique company-specific information that is relevant to the rate information provided.

Section 2 contains the same information, also in the same format, for the gas utilities. The only exception is the beginning comparison tables, which are divided between the 1307(f)<sup>2</sup> and GCR<sup>3</sup> gas utilities. The comparison tables in the beginning of each section show the total charges for each rate classification between all of the electric and gas utilities. The individual company rate tables detail the separate pieces that make up the total charges for each rate classification. While the beginning tables of each section present the easiest measure of comparison for rates, the Commission encourages readers of this report to examine the full contents of Sections 1 and 2, to understand the components that make up the rate for any company and any unique situations that may affect the company's rates.





## Citizens' Electric Company

Citizens' Electric Company, a subsidiary of C&T Enterprises Inc., serves roughly 5,500 residential, 1,000 commercial and 40 industrial customers. Their service territory consists of Lewisburg Borough and the townships of East Buffalo, Buffalo and Kelly in Union County, as well as West Chillisquaque in Northumberland County. Citizens' operates under the terms of Electric Tariff Pa. P.U.C. No. 14. With a service area of only 55 square miles, Citizens' is one of the smallest electric companies both in area and in number of customers included in this rate comparison. C&T Enterprises Inc. is a holding company owned by the Claverack and Tri-County Rural Electric Cooperatives for their for-profit enterprises. C&T also owns Valley Energy Inc. (gas) and Wellsboro Electric Company. Citizens' was engaged in a long-term contract to purchase power that expired this past year. Consequently, they had to purchase their power on the wholesale competitive market, leading to large increases in generation rates.

## Duquesne Light Company

Duquesne Light, a subsidiary of Duquesne Light Holdings, serves approximately 525,000 residential, 54,000 commercial and 1,440 industrial customers. The service territory consists of parts of Allegheny and Beaver counties, in Western Pennsylvania. Duquesne Light operates under the terms of Electric Tariff Pa. P.U.C. No. 24. Duquesne Light Holdings was recently acquired by a consortium led by the Macquarie Group, which is a diversified international financial services organization based in Australia. This acquisition was originally announced on July 5, 2006, and became official on May 31, 2007, with approval from FERC and the PAPUC.

The total service area is roughly 3,300 square miles. Met-Ed operates under the terms of Electric Tariff Pa. P.U.C. No. 50. ## Pike County Light & Power Company

Pike County Light & Power Company (Pike), a subsidiary of Orange & Rockland Utilities Inc. serves approximately 3,600 residential and 970 commercial customers. Pike's service territory consists of Westfall, Milford and Dingman (northern section) townships, and Matamoras and Milford boroughs in Pike County, Northeastern Pennsylvania. Pike operates under the terms of Electric Tariff Pa. P.U.C. No. 8. Pike also provides natural gas service in Pennsylvania in Westfall Township and Matamoras Borough, Pike County. Orange & Rockland Utilities Inc. (O&R) through subsidiaries Pike County Light & Power and Rockland Electric Company, provide service to roughly 296,000 electric and 126,000 natural gas customers. 


