In its Complaint Verizon asserted that the negotiated rates charged by FirstEnergy under their several Joint Use Agreements are “unjust and unreasonable.” On 2/3/20, FirstEnergy filed proprietary and non-proprietary versions of its Answer to Verizon’s Complaint, arguing that Verizon’s Complaint is unfounded, and should either be dismissed or the relief requested should be denied. Following transfer of the proceeding to the Commission, the matter was assigned to Deputy Chief ALJ Cheskis. By Recommended Decision issued on 9/15/20, ALJ Cheskis granted Verizon’s Complaint in part and denied it in part. FirstEnergy and Verizon filed proprietary and non-proprietary versions of their Exceptions on 9/22/20 and proprietary and non-proprietary versions of Reply Exceptions on 9/28/20.
