Withdraws Supplement No. 78 to Tariff Electric Pa. PUC No. 3
Residential Real Time Pricing (RRTP)

Dear Mr. McNulty:

On March 14, 2008, PECO Energy filed Supplement No. 78 to Tariff Electric Pa. P.U.C. No. 3 filed to become effective August 14, 2008. Subsequently, Supplement No. 80 suspended for a period of up to five months the rates proposed in Supplement No.78 to Tariff Electric Pa. P.U.C. No. 3 at Docket No. R-2008-2032333. A Joint Petition for Settlement was filed on August 29, 2008. An ALJ Recommended Decision was issued on September 23, 2008 recommending approval of the settlement.

On November 24, 2008, the Pennsylvania Public Utility Commission ("Commission") adopted a Tentative Order that provides, among other things, that "within sixty (60) days of entry of this Tentative Order, PECO Energy Company may withdraw its Petition for Approval of Phase I of its Residential Real Time Pricing Program." As such, PECO Energy has chosen to withdraw the RRTP Petition and encloses herewith an original and two copies of Supplement No. 84 to Tariff Electric No. 3. The purpose of this filing is to withdraw Supplement No. 78 to Tariff Electric No. 3. Presently, effective rates contained in Tariff Electric Pa PUC No. 3 and supplements thereto will continue in effect until otherwise amended.
