

MOTION FOR CONTINUANCE OF HEARING DATE

PECO Energy Company ("PECO Energy"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. An initial in-person hearing in this matter is currently scheduled for Thursday, February 19, 2009 at 1:30 pm.
2. Complainant previously indicated to PECO that he was thinking of withdrawing his complaint.
3. PECO spoke to Complainant today to discern the status of his Complaint.
4. Complainant indicated today that he felt his current bill was high and requested a high bill field investigation.
5. A field visit could not be scheduled any sooner than February 27, 2009, which would be 8 days after the hearing date.
6. Therefore, PECO is requesting that the hearing date be continued until after the high bill field investigation is completed on February 27, 2009.


