**MOTION FOR CONTINUANCE OF HEARING**

Pursuant to 52 Pa. Code § 1.15(b), Philadelphia Gas Works (hereinafter “Respondent”) hereby requests a continuance of the hearing in this matter scheduled for Thursday, February 26, 2009, and in support thereof states as follows:

1. On June 30, 2008, Complainant filed a Formal Complaint against the Philadelphia Gas Works (hereinafter “Respondent”).
2. On August 7, 2008, Respondent filed an Answer to the Complaint.
3. By Notice dated September 16, 2008, the Commission scheduled the Initial hearing of this matter for December 3, 2008 before Administrative Law Judge Angela T. Jones.
4. By order of Administrative Law Judge Angela T. Jones dated December 3, 2008, the Commission granted the Complainant’s request for a continuance of the Initial hearing in order to permit the Complainant to search her paperwork that had been packed away in storage when she moved from 7272 Lynford Street, Philadelphia, PA.
5. The Complainant now resides at 420 Parlin Street, Philadelphia, Pennsylvania 19116 but is not the Customer of Record for gas service at that address.
6. By Notice dated December 5, 2008, the Commission scheduled the Initial hearing of this matter for February 26, 2009 before Administrative Law Judge Angela T. Jones.

7. By letter dated January 23, 2009, the Respondent invited the Complainant to have a settlement conference to resolve the above captioned matter. To date the Complainant has not responded. The Respondent has also attempted to contact the Complainant by the telephone numbers indicated in the Complaint. The "home" telephone number, 215-305-0237, is not in service. The "work" telephone number 215-219-0957 is in service but Respondent could only leave a voice mail message.


8. By e-mail dated February 10, 2009, the Commission scheduled a meeting for February 26, 2009 at 2:00 p.m. at the Keystone Building in Harrisburg, PA, to provide feedback and instruction on the Commission's recently implemented "Electronic Filing" program, whereby parties may file pleadings and other documents with the Commission electronically.

9. Although the Initial Hearing in the above captioned matter is scheduled to begin at 10:00 a.m. on February 26, 2009, in order for Counsel for the Respondent to arrive timely at the Electronic Filing meeting, he must ride the train that leaves at 11:00 a.m. from Philadelphia 30<sup>th</sup> Street Station. The hearing, if not continued would prevent Counsel for Respondent from arriving timely at the Electronic Filing meeting.

**WHEREFORE**, The Respondent therefore requests that the Commission continue the hearing scheduled for February 26, 2009 in the matter to a date soon after February 26, 2009.
