

**PETITION FOR LEAVE TO WITHDRAW THE
APPLICATION OF PPL ELECTRIC UTILITIES CORPORATION TO
EXERCISE THE POWER OF EMINENT DOMAIN TO ACQUIRE AN EASEMENT
AND RIGHT-OF WAY ACROSS THE PROPERTY OF RANDAL W. ROWE, SANDY K.
ROWE, AND GERMAINE MICHELE COLE**

TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

PPL Electric Utilities Corporation (“PPL Electric”), by and through its attorneys, petitions for leave to withdraw and terminate the Application of PPL Electric Utilities Corporation to Exercise the Power of Eminent Domain to Acquire an Easement and Right-of-Way Across the Property of Randal W. Rowe, Sandy K. Rowe, and Germaine Michele Cole, pursuant to 52 Pa. Code §§ 1.82, 5.94(c), and in support thereof, states:

1. On January 28, 2009, PPL Electric filed the “Application Of PPL Electric Utilities Corporation Under 15 Pa. C.S. §1511(c) For A Finding And Determination That The Service To Be Furnished By The Applicant Through Its Proposed Exercise Of The Power Of Eminent

Domain To Acquire A Right-Of-Way And Easement Over And Across The Lands Of Randal W. Rowe, Sandy K. Rowe, and Germaine Michele Cole In Archbald Borough, Lackawanna County For The Proposed Susquehanna-Roseland 500 kV Transmission Line In Portions Of Lackawanna, Luzerne, Monroe, Pike And Wayne Counties, Pennsylvania Is Necessary Or Proper For The Service, Accommodation, Convenience Or Safety Of The Public,” which was docketed at Docket No. A-2009-2088357 (“Condemnation Application”).

2. On February 6, 2009, Administrative Law Judge Susan D. Colwell issued a Second Prehearing Order that, *inter alia*, consolidated the Condemnation Application with the above-captioned matters.

4. To date, no party has contested or otherwise formally opposed the Condemnation Application.

5. After filing of the Condemnation Application, PPL Electric has continued negotiations with landowners in the vicinity of the proposed transmission line, and has reached agreement with several landowners to slightly reroute the Susquehanna-Roseland 500 kV Transmission Line proposed in the "Application of PPL Electric Utilities Corporation Filed Pursuant to 52 Pa. Code Chapter 57, Subchapter G, for Approval of the Siting and Construction of the Pennsylvania Portion of The Proposed Susquehanna-Roseland 500 kV Transmission Line in Portions of Lackawanna, Luzerne, Monroe, Pike and Wayne Counties, Pennsylvania," docketed at Docket Number A-2009-2082652.


6. As a result of the above-mentioned rerouting, the Susquehanna-Roseland 500 kV Transmission Line avoids the property of Randal W. Rowe, Sandy K. Rowe, and Germaine Michele Cole in its entirety and, therefore, renders the Condemnation Application unnecessary.

7. Pursuant to Sections 1.82 and 5.94(c) of the Regulations of the Pennsylvania Public Utility Commission, 52 Pa. Code §§ 1.82, 5.94(c), PPL Electric seeks to withdraw and terminate the Condemnation Application in its entirety.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests Administrative Law Judge Susan D. Colwell permit PPL Electric to withdraw the Condemnation Application and terminate the proceeding docketed at Docket No. A-2009-2088357.
