PECO Energy Company ("PECO Energy"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. An initial telephonic hearing in this matter is currently scheduled for Thursday, March 26, 2009 at 10:00 am.

2. PECO recently spoke to Complainant and she indicated that she wished to expand the issues raised in her Formal Complaint to include a high bill dispute. Complainant did not raise a high bill dispute in her Formal Complaint filed on October 24, 2008.

3. PECO has agreed to perform a high bill field visit at Complainant's property. However, PECO has not yet been able to secure a date for the field visit with Complainant. PECO will be unable to perform a field visit at Complainant's property until after the hearing date because of other field visits currently scheduled.


4. PECO would like to address Complainant's new issue in the context of this Formal Complaint.




