On September 10, 2008, PECO Energy filed Supplement No. 82 to Tariff Electric Pa. P.U.C. No. 3 filed to become effective April 1, 2009. On March 12, 2009 the Pennsylvania Public Utility Commission adopted an Order that approved the Market Rate Transition Phase In Program Settlement, which, in effect, renders Supplement No. 82 mute.
