PETITION TO INTERVENE OF SOLAR SERVICES, LLC

Solar Services, LLC (“Solar Services”), through its attorneys, petitions to intervene in the above-captioned matter, pursuant to 52 Pa. Code §§ 5.71-5.75. In connection with its Petition, Solar Services represents as follows:

1. Solar Services is a Pennsylvania limited liability company located in Shoemakersville, PA, specializing in assisting with the establishment of solar projects for residential, commercial and industrial customers in Pennsylvania and elsewhere in the region.

3. On or about March 3, 2009, PECO Energy Company ("PECO") filed a petition requesting Commission approval of its Request-for-Proposal ("RFP") to procure up to 8,000 Tier I solar Alternative Energy Credits ("AEC" or “Solar AEC”) annually for a 10-year period. In its Petition, PECO requested, among other things, that it be permitted to recover all costs related to and in compliance with its RFP.


4. Eligibility to intervene in Commission proceedings is governed by the Commission's rule at 52 Pa. Code § 5.72. Under Section 5.72, a "right or interest" sufficient to warrant intervention includes an interest which may be directly affected and which is not adequately represented by existing participants, and as to which the petitioner may be bound by the action of the Commission in the proceeding; or, another interest of such nature that participation of the petitioner may be in the public interest.

5. Solar Services meets the standards set forth above. As previously mentioned, Solar Services is a Pennsylvania company that specializes in assisting with the establishment of solar projects for residential, commercial and industrial customers in Pennsylvania and elsewhere in this region. The PECO Petition, if granted, will assist Solar Services in its business of seeking to establish solar projects. If granted, the PECO Petition will greatly assist in establishing market prices for Solar AECs, which will greatly enhance the ability of solar projects to move from planning stages to the point where bids for the sale of Solar AECs can be offered. Thus, as a broker of solar projects, Solar Services has a direct interest in the PECO Petition receiving Commission approval. To Solar Services' knowledge, no party to this proceeding directly represents its solar industry interests. Therefore, there is no existing party in the case that can be deemed to adequately represent solar industry interests in this proceeding.

6. Solar Services accepts the procedural schedule that has been established in this case without modification. In addition, Solar Services will be an active participant in the litigation of this case, including participation in settlement discussions.

WHEREFORE, for all the foregoing reasons, Solar Services, LLC respectfully requests that its Petition to Intervene be granted and that the Commission grant it such other relief as is just and reasonable under the circumstances.


