Dear Ms. Bullock:

Per our conversation today, this letter confirms settlement of the above-referenced Public Utility Commission (PUC) Complaint.

PECO has agreed to credit your account an additional \$100.00 as a good faith business credit. This fully resolves all issues raised in your current Formal Complaint, and all issues related to the settlement agreement resulting from your prior Formal Complaint at Docket Number C-20042980.

Additionally, PECO has offered to conduct a high bill field investigation. This investigation requires field representatives to visit your home and conduct an analysis. Mr. Lou Dubois will contact PECO's High Bill Department to initiate the investigation. In turn, a high bill representative will contact you schedule an appointment. Please note that if you do not permit the field representatives to enter your home and conduct the analysis, the high bill investigation will cannot be completed.

I am including the Withdrawal of Complaint form and ask that you please sign and return it in the envelope provided at your earliest convenience.

I will forward a Certificate of Satisfaction to the appropriate office at the PUC. Unless you file a written objection to the PUC within ten (10) days, the Certificate of Satisfaction will be sufficient confirmation for the PUC that the above-referenced complaint has been withdrawn and the file may be closed.

This letter contains the entire terms of the settlement agreement between you, Janice Bullock, and PECO Energy Company. Any other terms or promises, written or oral, not incorporated in the body of this letter will not be a part of this settlement agreement and, therefore, will be void.


