
Dear Secretary McNulty:

This correspondence is submitted on behalf of Qwest Communications Company ("QCC") to place on the record its position regarding continuation of the Pennsylvania Public Utility Commission's ("Commission") stay of this investigation. Consistent with the Commission's orders in this proceeding, parties are to report on their position as to whether a stay of these proceedings should continue. QCC is a party to this proceeding. Recently, the Commission has acted to lift the stay of its investigation of access charge issues in the rural local exchange carrier proceeding at Docket No. I-00040105. However, it has always treated these dockets separately.

QCC considers the issue of whether the stay of the investigation of Verizon Pennsylvania, Inc.'s and Verizon North, Inc.'s access charges should continue, or be ended, to be a policy decision to be made by the Commission, based on its judgment and expertise. QCC therefore neither supports or opposes continuation of the stay at this time.
