

Dear Secretary McNulty:

This letter is to inform you of a settlement of a part of the above referenced complaint. The complaint concerned the rate case that is ongoing and the complaint of a wet spot in yard of the complainant (Mr. Lee Wotanis) and his neighbor, Mr. George Pitely. The rate case portion of the complaint was not resolved.

The complaint of the wet spot in the yard was discussed in a meeting today between the Company and Mr. Wotanis and Mr Pitely. As the water line is approximately 40 feet from the wet spot, and leak detection of the nearest water line did not produce evidence of a leak, it was agreed that most probably, the wet spot is caused by ground water. Mr. Wotanis and Mr. Pitely, agreed to install a French drain in the yard at no expense to the Company. When this construction is to take place, Mr. Pitely and Mr. Wotanis will inform the Company so a representative can be present. The Company requested, and it was agreed, that the French drain would daylight before entering Lake Spangenberg.

The Company and Mr. Wotanis are satisfied with this resolution. We hereby request that the PAPUC satisfy this matter.
