

Residential/Small Bus. Under 25kW Disclosure Statement for Electric Generation Suppliers

This is an agreement for electric generation service between BlueStar Energy Services, Inc. and <CUSTOMER NAME> located at <SERVICE ADDRESS>.

Background

- We at BlueStar Energy Services, Inc. are licensed by the Pennsylvania Public Utility Commission to offer and supply electric generation services in Pennsylvania. Our PUC license number is A-2009-2132755.

- If you ask us, we can bill you directly for our service.
- Right of Rescission. You may cancel this agreement at any time before midnight of the third business day after receiving this disclosure.

Definitions

- Generation Charge. Charge for production of electricity.
- Transmission Charge. Charge for moving high voltage electricity from a generation facility to the distribution lines of an electric distribution company.
