
Dear Secretary McNulty:

On October 30, 2009, PPL Electric Utilities Corporation ("PPL Electric") filed the above-referenced Petition with the Pennsylvania Public Utility Commission ("Commission"). The Petition requests that the Commission approve a temporary increase to the annual maximum CAP credits under PPL Electric's OnTrack program from \$700 to \$900 for non-heating customers and from \$1,800 to \$2,300 for heating customers. On October 23, 2009, a Notice of Intervention was filed by the Office of Consumer Advocate ("OCA"). Subsequently, a Notice of Appearance was filed by the Office of Trial Staff ("OTS").

The undersigned counsel for PPL Electric has contacted counsel for OCA and OTS, and was advised that neither party had objections to the Petition. As the Petition is unopposed, PPL Electric respectfully requests that the Commission approve the Petition at the earliest possible date, in order to avoid the potential removal of customers from PPL Electric's OnTrack program who might exceed the current maximum annual level in early 2010, following expiration of PPL Electric's generation rate cap.


