PUBLIC STATEMENT OF THE 62.142
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention and Answer and participate in proceedings before the Commission involving the Petition of PECO Energy Company (PECO) for Approval of Its Revised Electric Purchase of Receivables (POR) Program. PECO filed its Petition seeking approval of changes to a program which allows Electric Generation Suppliers (EGSs) to sell certain accounts receivables for electric supply service provided in PECO's service territory to PECO. The EGS is paid by PECO for the receivable, providing the EGS with more certain cash flow and a reduced need for full billing systems.

PECO has proposed changes to its POR Program based in part on terms and conditions agreed to by PECO as part of a settlement approved by the Commission in a different but related PECO case. The Consumer Advocate was a party to that settlement. The Consumer Advocate has determined to intervene in this Petition proceeding to assure that the provisions of the settlement are complied with. Additionally, the OCA has intervened to assure that changes to PECO's POR Program include all appropriate consumer protections, consistent with the Public Utility Code and Commission regulations. Finally, the OCA has intervened to assure that PECO's changes to its POR Program do not impose costs on PECO's distribution service customers which should be recovered from the EGSs.
