Dear Attorney Schneider:

I have received a copy of the January 29, 2010, letter you sent to Secretary McNulty regarding the above referenced formal complaint. I am answering your letter to clarify the status of the Docket.

On December 9, 2009, Attorney Andrew Ralston, for PPL filed a Certificate of Satisfaction with the Commission and copied you. A copy of the Certificate was attached to your letter. Rules pertaining to Certificates of Satisfaction are found at 52 Pa. Code § 5.24.

You responded to the Certificate on December 15, 2010, and the Secretary's Bureau records show it was received on December 16, 2010. However, after reviewing your letter I see that the letter does not state any specific objection, nor even state that your client objects to the Certificate at all; it simply states "To the extent that the Certificate of Satisfaction of Complaint is not in accordance with the letter from Mr. Figura, my client objects to the Certificate of Satisfaction." (Emphasis in original.) As a result of that lack of specificity, the Certificate of Satisfaction acted as final closure of the Docket. Neither an ALJ nor the Secretary's Bureau will make a determination concerning your client's objections for him.

If your client continues to have any objection to the Docket being closed feel free to file a petition to reopen the Docket *nunc pro tunc* and in the petition list with specificity your client's objections.


