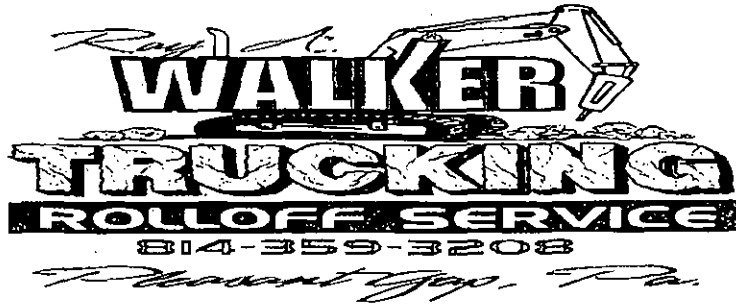
Pursuant to 52 Pa. Code § 5.94, Law Bureau Prosecutory Staff and the Bureau of Transportation hereby request that the outstanding complaint at Docket No. C-2009-2137034 filed on December 2, 2009, and served upon Ray A. Walker, be withdrawn as moot because Mr. Walker filed an Answer indicating he has no intent to abandon service, but that his annual assessment report was \$0 because of economic down turn. He further stated that with the increase in drilling for natural gas in Central Pennsylvania, he has been receiving inquiries for hauling heavy equipment, thus, he will likely have assessable revenues to report going forward. If there is no objection to this request for withdrawal by Ray A. Walker within twenty days, we ask that Docket No. C-2009-2137034 be closed.
