
Dear Ms. Keezel:

I am requesting reconsideration to the January 28, 2010 order by the Commission, and allow us to respond at this time. I am doing so because the day after receiving the complaint I was out of the office for an extended period of time. I was out of town for 10 days. Upon my return, my sister was admitted to Hamot Hospital MICU where she proceeded to have respiratory failure, kidney failure and liver failure, and I ended up "camping out" because of the frail condition she was. During this medical crisis my sons became ill, with one getting the Swine Flu. Needless to say my presence at work was minimal. In December I did call your office and spoke with a "Dave" about getting a copy of the complaint because trying to work at the hospital, some items were misplaced in her unit. He looked for the information and said he "showed nothing on file". This past weekend I received the official notice of the order. I spoke with "Dave" again on Monday, February 1, 2010, which he recalled our conversation. He was going to have someone in your office call me, but as of yet, I have not heard anything.

If the commission would consider this, we would be greatly appreciative, this was not a business lack of response, it was solely a personal incident that interfered with the proper response being filed. As evidence of the issue, in our request for the 8 year exemption inspection of December 3, 2009, I apologized for the late timing of the request due to family health problems, copy enclosed.

I hope that you will decide in our favor on this request. I thank you in advance.
