PUBLIC STATEMENT OF THE  
OFFICE OF CONSUMER ADVOCATE  
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention and participate in proceedings before the Commission involving the proposed tariff filed by PPL Electric Utilities Corporation (PPL).

On December 18, 2009, PPL filed Supplement No. 78 to Tariff Electric Pa. P.U.C. No. 201 in compliance with a Secretarial letter issued on December 17, 2009. Supplement No. 78 indicates revised Competitive Transition Charges and revised Transmission Service Charges, Universal Service Rider and Remand Rider -1 charges, as well as Generation Suppler Charges, to be effective on January 1, 2010

The Consumer Advocate files this Notice of Intervention to ensure that the rates contained in Supplement No. 78 sought by the Company are just and reasonable and based upon information filed by the Company in support of its claim. The Consumer Advocate will represent the interests of PPL's consumers before the Commission and seek to ensure that customers are not charged rates that are unjust, unreasonable, discriminatory or otherwise contrary to law.
