Dear Secretary McNulty:

PPL Electric Utilities Corporation ("PPL Electric") hereby submits this Certificate of Satisfaction pursuant to 52 Pa. Code § 5.24(b)(1). In their Complaint, the Raubs generally averred that certain of PPL Electric's facilities near their farm were not safe or adequately maintained. In the Answer, PPL Electric denied those averments.

PPL Electric has been in contact with the Raubs' attorney. In those discussions, PPL Electric explained that certain of the facilities about which the Raubs had expressed concern are owned by the local telephone exchange carrier, not PPL Electric. Those facilities have now been removed by that local exchange carrier. In addition, in order to settle this proceeding, PPL Electric agreed to remove certain of its facilities and replace one utility pole and guy with a stronger pole that will not require a guy, all at its expense. The Raubs and PPL Electric have settled the proceeding based on this agreement. The Raubs have indicated to PPL Electric that they are satisfied with the settlement.

As indicated by the enclosed certificate of service, a copy of this Certificate of Satisfaction is being served upon the Raubs' attorney. The Raubs may object to this Certificate of Satisfaction. If they do, they should submit their objection in writing to the Secretary of the Pennsylvania Public Utility Commission ("Commission") within ten (10) days of this Certificate of Satisfaction with a copy of their objection to me. If the Raubs do not object to this Certificate of Satisfaction, PPL Electric requests that the Commission mark the Complaint proceeding closed.




