OBJECTION TO SETTLEMENT



The objection is to the payment plan articulated in ¶ 4 therein. Plaintiff agrees to an outstanding balance of \$3,000 (THREE THOUSAND DOLLARS), but under the payment plan as articulated by PGW (\$287 per month for 60 months), Plaintiff would be paying a total of \$17,220.

Pursuant to your settlement conference held on March 2, 2010, with Anne Marie Cromley, Senior Customer Review Officer – PGW, and your agreement with Mr. Thomas Coker, your landlord by memo dated February 12, 2010, regarding this matter which is attached, this letter confirms the terms of settlement, in the above captioned matter.

In complete settlement of all issues in this matter, you have discussed your concerns with your account. The parties acknowledge and agree to the following:

1. This matter concerns the discovery of and responsibility for "foreign load" at the gas service for 7200 Devon Street, Apt. 2, Philadelphia, Pennsylvania, PGW Account No. 8119396440 (Service Address). The outstanding account balance is \$4,887.59.
2. PGW will waive \$423.87 in late payment charges, bringing the outstanding balance to \$4,463.72.
3. PGW will apply a revenue credit adjustment of \$1,463.72 to your account, bringing the outstanding balance to \$3,000.00.
4. You have entered into a payment agreement consisting of the payment of the PGW budget plan (currently \$237) plus \$50 toward the outstanding for a total of \$287 per month for 60 months.
5. You understand that the PGW budget plan amount is subject to review and adjustment three times each year depending upon your usage patterns.
6. You have indicated that you are satisfied with the treatment of your account and no longer wish to pursue the above captioned matter.
