**Re: Request for Waiver of 52 Pa. Code § 71.3 –

Dear Mr. McNulty:

On March 31, 2010, PPL Electric Utilities Corporation ("PPL Electric") filed a request with the Commission for a general rate increase of \$114.7 million, pursuant to Section 1308 of the Public Utility Code, 66 Pa. C.S. § 1308. As part of the voluminous documentation filed in support of its request for this general rate increase, PPL Electric provided financial data for the 12 months ended December 31, 2009. This data, which forms the basis for PPL Electric's historic test year, is set forth in Exhibit Historic I at Docket No. R-2010-2161694.

The data set forth in Exhibit Historic I, at the above-indicated proceeding, provides the same information as that data to be included in the quarterly financial report for the 12 months ended December 31, 2009, which is required pursuant to Section 71.3 of the Commission's regulations, 52 Pa. Code § 71.3. Accordingly, PPL Electric hereby requests that the Commission grant a waiver from Section 71.3 of its regulations for the quarterly financial report associated with the 12-month period that ended on December 31, 2009.

Pursuant to 52 Pa. Code § 1.11, the enclosed document is to be deemed filed on March 31, 2010, which is the date it was deposited with an overnight express delivery service as shown on the delivery receipt attached to the mailing envelope.
