





**PPL ELECTRIC UTILITIES CORPORATION MOTION
TO CONSOLIDATE THE ABOVE-CAPTIONED PROCEEDINGS**

TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) hereby moves, pursuant to 52 Pa. Code § 5.81, to consolidate the above-captioned: (1) Complaint of David L. Fisher and Robert A. Kurrell at Docket No. C-2010-2160921, and (2) the Complaint of Robert A. Kurrell at Docket No. C-2010-2164071. Both of the above-captioned Complaints raise issues regarding PPL Electric’s recent default service rate increase, and both Complaints relate to the same service address and account number. It will be more efficient to address the issues raised in the Complaints if they are addressed in one, consolidated proceeding. In support of this Motion, PPL Electric states as follows:

1. On or about January 29, 2010, David L. Fisher filed a Complaint that was docketed to C-2010-2160921. The gravamen of the Complaint involved the increase in PPL Electric’s default service rates that occurred on January 1, 2010, following the expiration of PPL

Electric's generation rate caps. In the Complaint, Mr. Fisher indicated that he also was filing the Complaint on behalf of Mr. Robert A. Kurrell and that the Complaint related to service provided to 559 Treva Road, Paxinos, Pennsylvania at account number 50958-45001.

2. PPL Electric filed a timely Answer to Mr. Fisher's Complaint at Docket No. C-2010-2160921.


3. On or about March 1, 2010, Mr. Kurrell filed a Complaint that was docketed at C-2010-2164071. This Complaint also raised issues regarding the recent increase in PPL Electric's default service rates following the expiration of the Company's rate caps and also is related to service provided to 559 Treva Road, Paxinos, Pennsylvania at account number 50958-45001.

4. PPL Electric is filing an Answer to Mr. Kurrell's Complaint contemporaneously with this Motion.

5. As explained above, both the Complaints filed by Mr. Fisher and Mr. Kurrell involve the same service address, the same customer account and similar issues. It will be more efficient to resolve the issues raised in the two Complaints in one consolidated proceeding.

WHEREFORE, for the foregoing reasons stated above, PPL Electric Utilities Corporation respectfully requests that the Pennsylvania Public Utility Commission enter an order consolidating: (1) the Complaint filed by Mr. Fisher and Mr. Kurrell at Docket No. C-2010-2160921, and (2) the Complaint filed by Mr. Kurrell at Docket No. C-2010-2164071.


