

# SETTLEMENT AGREEMENT

On March 23, 2010 Margaret A. Mueller of Duquesne Light Company contacted Rose D. Foulks to discuss settlement of her Formal Complaint.

A settlement agreement was reached between Ms. Mueller, representing Duquesne Light Company and Ms. Foulks (Account No. 3000844215002). It was agreed that we would remove the \$250 reconnect charge and \$106 security deposit placed on her account on September 29, 2009. Ms. Foulks agreed to pay a total of \$56 which represents a \$50 reconnect fee and \$6 towards her account balance. As a customer courtesy, we will waive the \$106 security deposit.
