The Clarion Wastewater Operations (the "Company") of Pennsylvania American Water is herewith filing for an increase in wastewater rates based on a future test year ending December 31, 2010. In support of that request, PAW submits the following documents:

PENNSYLVANIA AMERICAN WATER FILES RATE REQUEST FOR CLARION WASTEWATER SYSTEM

Proposed rates driven by \$2.7 million capital investment

CLARION, Pa. (April 23, 2010) -- Pennsylvania American Water today filed a request with the Pennsylvania Public Utility Commission (PUC) to increase sewer rates for customers of its Clarion wastewater system.

Under the proposed new rates, the typical residential customer's wastewater bill would increase from \$21.52 per month to \$40.37. The company requested that the new rates become effective June 22, 2010, however the PUC typically suspends such requests for up to six-to-nine months to permit a complete investigation and analysis.

Pennsylvania American Water President Kathy L. Pape said, "The proposed increase is needed to help recover approximately \$2.7 million that our company will have invested since acquiring the system to address past environmental issues and to improve the quality and reliability of wastewater service. Our significant capital investment equates to spending approximately \$1,200 per customer in the Clarion area."

This request is Pennsylvania American Water's first since acquiring the system in October 2008. The company's capital improvements include \$2.2 million for collection system upgrades and \$500,000 to enhance the treatment system's reliability.

Pape noted that the system upgrades are required to begin to resolve environmental issues that the Pennsylvania Department of Environmental Protection identified in a Consent Order dated October 30, 2008, pertaining to an overload of the sanitary sewer system. She said the rate increase is also needed to recover increased operational expenses, such as electricity, treatment chemicals and labor.

In its rate case filing, Pennsylvania American Water is proposing to establish an assistance fund through the H2O (Help to Others) Program™ to help disadvantaged customers with their wastewater bills. It would be administered in the same manner as the existing H2O Program for water customers who qualify. Pape said the company is proposing to contribute \$10,000 to create an assistance program that provides grants and service fee discounts for those wastewater customers who qualify.

Pennsylvania American Water provides wastewater service to approximately 2,200 customers in Clarion Borough, Clarion Township and Monroe Township.

The rate case filed by Pennsylvania American Water requests an increase in annual wastewater revenues of approximately \$968,817. Customers with additional questions can contact the company's customer service center at 1-800-565-7292.
