The Coatesville Wastewater Operations (the "Company") of Pennsylvania American Water is herewith filing for an increase in wastewater rates based on a future test year ending December 31, 2010. In support of that request, PAW submits the following documents:

PENNSYLVANIA AMERICAN WATER FILES RATE REQUEST FOR COATESVILLE WASTEWATER SYSTEM

Proposed rates driven by \$57.7 million capital investment

COATESVILLE, Pa. (April 23, 2010) -- Pennsylvania American Water today filed a request with the Pennsylvania Public Utility Commission (PUC) to increase sewer rates for customers of its Coatesville wastewater system.

Under the proposed new rates, the typical residential customer's wastewater bill would increase from \$27.43 per month to \$90.26. The company requested that the new rates become effective June 22, 2010, however the PUC typically suspends such requests for up to six-to-nine months to permit a complete investigation and analysis.

Pennsylvania American Water President Kathy L. Pape said, "The proposed increase is needed to help recover approximately \$57.7 million that our company will have invested to improve wastewater service and reliability since the last rate case in 2008. Our significant capital investment equates to spending approximately \$9,500 per customer in the Coatesville area."

The company recently completed a major upgrade and expansion of the Coatesville Wastewater Treatment Plant at a cost of approximately \$55 million, replacing an outdated facility dating back to 1932. The new state-of-the-art facility ensures that the system complies with all environmental regulations, while providing enhanced odor control and beneficial reuse of wastewater residuals. In addition, Pennsylvania American Water invested in improvements to the sewer collection system.

Pape noted that the upgrades were required to resolve environmental issues that the Pennsylvania Department of Environmental Protection had identified in a Consent Order dated November 30, 2005, pertaining to a projected hydraulic overload at the wastewater plant. She said the rate increase is also needed to recover increased operational expenses, such as electricity, treatment chemicals and labor.

In its rate case filing, Pennsylvania American Water is proposing to establish an assistance fund through the H2O (Help to Others) Program™ to help disadvantaged customers with their wastewater bills. It would be administered in the same manner as the existing H2O Program for water customers who qualify. Pape said the company is proposing to contribute \$10,000 to create an assistance program that provides grants and service fee discounts for those wastewater customers who qualify.

Pennsylvania American Water provides wastewater service to approximately 6,000 customers in Coatesville, Parkesburg, and the townships of East Fallowfield, Caln, West Caln, Valley, Sadsbury, West Sadsbury, Highland and West Brandywine.
