RESTRICTIVE AMENDMENT AND  
WITHDRAWAL OF PROTESTS STIPULATION

1. Ramsey's Moving Systems, LLC hereby restrictively amends this application to seek the following authority:

Household goods in use, from points in Chester and Montgomery Counties, excluding the municipalities of Coatesville, Pottstown and Lansdale, to points in Pennsylvania, and vice versa.

Subject to the following conditions:

That no right, power or privilege is granted to provide service to or from points in the Counties of Allegheny, Washington and Centre.

That no right, power or privilege is granted to provide service to or from points located within twenty-five (25) statute miles of limits of the City of Altoona, Blair County.

That no right, power or privilege is granted to provide service to or from points located within fifteen (15) miles by the usually traveled highways of the limits of the City of Allentown, Lehigh County, or within three (3) miles of the limits of the City of Easton, Northampton County.


2. Based upon the foregoing restrictive amendment and specifically

contingent upon the acceptance of the restrictive amendment by the Commission, and any grant of authority being consistent with the restrictive amendment, Protestants, Hoy Transfer, Inc., Starck Van Lines, Inc. and Lytle's Transfer & Storage, Inc. (hereinafter referred to as "Protestants"), by and through their counsel, have stipulated to the withdrawal of their opposition to the above captioned application, provided that the restrictive amendment is accepted and approved by the Commission. In the event that the Commission does not accept and approve the foregoing restrictive amendment, it is agreed and understood that the protests of the foregoing Protestants shall not be withdrawn and that Protestants shall be entitled to continue their opposition to the application. Attached hereto as Appendix "A" is the signed Withdrawal of Protest Stipulation on behalf of Protestants.

3. The aforesaid Protestants will remain of record for the purpose of receiving copies of all notices and orders issued in this proceeding. The representative of the Protestants is as follows:
