Dear Mr. Diaz, Jr.:

On February 26, 2010, the Bureau of Transportation and Safety instituted a Complaint against William Joseph Diaz, Jr. d/b/a Ashley's Stretched Limo Service, Respondent, alleging failure to file a tariff with its Limousine rates based solely on time with a minimum of 30 minute time periods and increments a violation of 52 Pa. Code §29.334, and the Complaint imposed a penalty of \$250.00.

The Complaint was served on the Respondent on March 1, 2010. On March 29, 2010, the Respondent filed an acceptable Tariff with a minimum of 30 minute time periods and increments, however, Respondent has failed to pay the fine.

Respondent shall pay **the fine of two hundred fifty dollars (\$250.00), within twenty (20) days from the date of this letter.** Payment must be by certified check or money order, payable to the Pennsylvania Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265, as provided in the Public Utility Code, 66 Pa. C.S. §§3301 and 3315.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§101, et seq. and the regulations of the Commission, 52 Pa. Code §§1.1, et seq.
