TO - Secretary of the Commission:

At the time I filed my complaint, I was unaware that a Mediation Service was an option. I was overwhelmed by the formal hearing process. The mediation process does not determine fault or deal with past issues.

I am not understanding the payment arrangement on April 10, 2009, because I had already filed a complaint on March 25, 2009.

I did request a down payment of \$1000 and monthly payments of \$500.

Ms. Tarpley testified that my history shows that I made an average of 6 payments per year. That was about 4 years ago, when I was going through cancer treatments.

I have been making consistent monthly payments, to reduce this past balance and pay the current monthly charges. This is my focus and priority. I am making progress. A down payment of \$1000 and monthly payments of about \$500, will satisfy this in about 11 months.


